Professional Services Agreement with KEI

RECOMMENDATION: That the Commission considers a motion to authorize the Utility Engineer to enter into an agreement with Kujawa Enterprises, Inc. (KEI) for installation of landscaping around the gate on the low lift drive in the amount not to exceed \$25,000.00.

The Engineering Department has been working on the landscaping design project for two years. KEI is the only landscaping company that was contacted about the project that responded with a design. The layout has been modified twice to accommodate the requests of the City for the types and locations of the plantings due to the soil cap on site. The planting materials are not permitted to have deep tap roots that could penetrate the soil cap covering the contamination. The landscaping will address the issue of site security. Currently, as seen in the 2018 aerial photos vehicles are driving around the gate to gain access to the road. The City is allowing the use of the extra retaining wall stones from the Lake Vista Park project to be incorporated in the design. This will tie the design to the City Park landscaping. The City is also providing the topsoil that is on site to create the planting berm. This is a benefit since the material has already been approved by the DNR as clean material available to be used on the site.

East Fitzsimmons Road Water Main Extension Contract Award

Project Nos.: 19102

Date: May 14, 2019

RECOMMENDATION: That the Commission consider a motion to approve the East Fitzsimmons Road Water Main Extension project and award a construction contract to the lowest responsive, responsible bidder, DF Tomasini Contractors, Inc., based on the bid amount of \$318,863.50.

This project relays 634 LF of 12" PVC water main along E. Fitzsimmons Road from 400 E Fitzsimmons Road to S. Darlene Lane and is part of the 2019 Capital Improvement Plan. The existing 12" ductile iron water main was installed in 1975 and has had several breaks. There have been 2 breaks on this section of main in the past 10 years and 4 breaks in the past 10-25 years. This section of main exceeds the partnership for Safe Water main break goals. This relay will be in advance of the City paving project anticipated in 2021. The engineering estimate on the project was \$335,992.00.

West College Avenue Water Main Extension Contract Award

Project Nos.: 19103

RECOMMENDATION: That the Commission consider a motion to reject all bids for the West College Avenue Water Main Extension project.

RaSmith prepared the plans and specifications for the project. The project installs 1850 LF of 12" PVC water main by directional drilling along W. College Avenue from 400 feet east of S. 27th Street to 525 feet west of S. 20th Street. It is part of the 2019 Capital Improvement Plan. The loop will connect two dead end lines along W. College Avenue. This will improve fire protection and water quality along this stretch. The special assessment for the project was approved by Council by Resolution 12052-041619. The engineering estimate on the project was \$535,376.00. The high bid price and low number of bidders is an indication that demand for underground contractors may have increased.

The work was advertised, and the following bid was received:

2018 Sanitary Sewer Rehabilitation Contract Award

RECOMMENDATION: That the Commission consider a motion to reject all bids for the 2018 Sanitary Sewer Rehabilitation project.

RaSmith prepared the plans and specifications for the project. The project consists of 3 sanitary spot repairs, 120 LF of 6" sanitary lateral relay, 8,847 LF of 8"-15" CIPP Liner and 1,487 LF of 8" to 10" Sanitary Relay in various location around the City. It is part of the 2018 Capital Improvement Plan. This is the third rehabilitation project on the sanitary sewer system in the past 3 years. The project improves the sections that show deterioration due to sags or cracks. The engineering estimate on the project was \$781,994.39. The high bid price and low number of bidders is an indication that demand for underground contractors may have increased.

I-94 & Puetz Road Water Main Crossing

Globe Contractors is finishing up the anode bed and restoration work.

Wildwood Drive Water and Sewer Replacement Project

The project was awarded to Willkomm Excavating and Grading. We held the preconstruction meeting for the project. As soon as we receive the DNR permits the work will begin. The contractor has a schedule of 2 months to complete the work. We will work with the City on the schedule so that the road project can proceed upon completion of the Utility work.

Forest Hill Avenue Water Main Replacement Project

Globe Contractors have completed the water main installation. Restoration work is expected to be completed as soon as the weather permits.

Water System Master Plan

CDM Smith continues to work on the water system master plan. Staff has gathered the information and submitted to the Consultant. They are currently reviewing the data and creating the model of the system.

DISTRIBUTION & COLLECTION OPERATIONS

April 2019

Water Main Breaks:

There were no main breaks in the month of April.

Water Lateral Repairs:

On April 2nd a crew was sent to 7869 South 13th Street to abandon a 1" lateral at the main.

Valve Repairs:

There were no valve repairs in the month of April.

Fire Hydrant Repairs:

There were no hydrant repairs in the month of April

Annual Hydrant Flushing:

Distribution crew started the annual flushing and greasing of 1762 fire hydrants, sampling 205 for chlorine residuals. Also, crews are completing directional flushing of water mains in sections of the city.

Sewer Repairs:

On April 18th a vacuum pump was replaced at the Jewell Street lift station.
